If you are a Host employer with BridgeUSA Summer Work Travel program participants in need of a Social Security Number, we encourage you to take advantage of our Northern Door program dates to schedule SSA appointments in Ephraim, instead of having to drive your students to Green Bay.

NO WAITING PERIOD

While there is normally a 10-day waiting period for international students to apply for their Social Security card, the waiting period has been waived for community outreach events like ours.

BY APPOINTMENT ONLY – BY EMPLOYER

We have approximately 4 hours to see three hundred students this year. To accomplish this, we need your commitment that you will work with each student to verify their application and documents are in order BEFORE THEY ARRIVE – and we need you to deliver them to the hall BEFORE their appointment time. *PLEASE NOTE: The SSA recently changed their application process. Please wait until we send you the updated easy-to-follow instructions before you start the application process.*

HOST EMPLOYERS – TO REQUEST YOUR APPOINTMENT(S)

Appointments are scheduled every 10-minutes – and we can see up to 10 students at a time.
