Resolution No. 2022-17 PROCLAMATION

TRAVEL & TOURISM WEEK MAY 1-7, 2022

TO THE DOOR COUNTY BOARD OF SUPERVISORS:

WHEREAS, Travel matters to the nation's economic prosperity and its image abroad, to business wealth and to individual travelers; and

WHEREAS, Travel to and within the United States provides significant economic benefits for the nation, generating \$1.5 trillion in economic output, including \$680.3 billion spent directly by travelers in 2020; and

WHEREAS, Travel is among the largest private-sector employers in the United States, supporting 11.1 million jobs in 2020, including 6 million directly in the travel industry and 5.1 million in other industries; and

WHEREAS, Travel spending directly generated tax revenues of \$112 billion in 2020 for federal, state and local governments, funds used to support essential services and programs; and

WHEREAS, direct tourism spending in Door County totaled \$304.2 million in 2020 and generated \$32.5 million in state and local tax revenue while supporting 2,743 jobs and generating \$80.4 million in employee wages; and

WHEREAS, International travel to the United States is one of the nation's largest single export industries. Travel generated \$83.3 billion in exports in 2020, creating a travel trade surplus of \$35.1 billion in favor of the U.S.; and

WHEREAS, Leisure travel, which accounts for 4 out of 5 domestic trips taken, spurs countless benefits to travelers' creativity, cultural awareness, education, happiness, productivity, relationships and wellness; and

WHEREAS, Travel is a catalyst that moves the county, state and national economy forward and are essential to get our economy moving again following the impacts of the pandemic.

NOW, THEREFORE, BE IT RESOLVED, that the Door County Board of Supervisors does hereby support and promote May 1-7, 2022 as Travel and Tourism Week in Door County, and urges the citizens of Door County to join in this special observance with appropriate events and commemorations.
